

**TOWN OF GUTTENBERG REQUEST FOR QUALIFICATIONS
FROM ATTORNEYS OR LAW FIRMS INTERESTED IN SERVING AS
“SUBSTITUTE MUNICIPAL PROSECUTOR”
TO THE TOWN OF GUTTENBERG
FOR THE PERIOD OF JUNE 1, 2018 TO DECEMBER 31, 2018**

Introduction

The Town of Guttenberg (“Town”) is a municipality of Hudson County, New Jersey. Pursuant to *N.J.S.A. 19:44A-20.5 et seq*, the Town seeks Requests for Qualifications (“RFQ”) from attorney or law firms licensed to practice law in the State of New Jersey that wish to serve as “Substitute Municipal Prosecutors” to the Town of Guttenberg, as directed by the Town Attorney or other appropriate officials within the Town. The successful firm must have significant experience in representing New Jersey municipalities in all aspects of criminal law. The successful firm will provide the Town with legal guidance relating to, but not necessarily limited to:

1. All necessary and desirable legal counsel and advice for the preparation and prosecution of cases as needed as the substitute municipal court prosecutor;
2. Conducting the prosecution of such cases except such crimes and offenses as it may be the duty of the County or State officials to prosecute;
3. Attend, schedule, and conduct such meetings with the Guttenberg Police Department and its police officers as are necessary to the successful prosecution of cases;
4. Any other matters as directed by the Municipal Court.
5. Notify the Town of changes in municipal law or state regulations, as well as Court decisions, that impact the operation of the Town; and
6. Cover second Court Session every Thursday, mornings and the regular Court Session on Tuesday evenings as may be required.
7. Any other matters as directed by the Town.

Professional Information and Qualifications

Each interested firm shall submit the following information:

1. Name of Firm;

2. Address of principal place of business and all attorneys or firm's offices and corresponding telephone and fax numbers. Please note specifically which attorneys will be assigned to serve in the position of Substitute Municipal Court Prosecutors ;
3. Areas of Practice;
4. Description of firm's attorneys' education, experience, qualifications, number of years with the firm and a description of their experience with positions similar to those described above;
5. Experience related to the prosecution of cases in Municipal Court in an urban environment in New Jersey which is substantially similar to the Town of Guttenberg;
6. At least four (4) references, three (3) of which must have knowledge of your municipal court and criminal law practice;
7. The firm's ability to provide the services in a timely fashion (including staffing, familiarity and location of key staff);
8. Statement of corporate ownership (c.52:25-24.2).
9. Any other information which the interested firm deems relevant.
10. New Jersey Business Registration Certificate.
11. Fully executed Non-Collusion Affidavit which is attached.
12. Fully executed Disclosure of Ownership form which is attached.
13. Mandatory Equal Employment Opportunity Language (if applicable).

Section Criteria

The selection criteria used in awarding a contract or agreement for professional services as described herein shall include:

1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation;
2. Experience and references;
3. Ability to perform the task in a timely fashion, including staffing and familiarity with the subject matter;
4. Cost competitiveness; and
5. Other factors, if demonstrated to be in the best interest of the Town.

DISCLOSURE OF OWNERSHIP FORM

EXHIBIT A

MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE

N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq.

GOODS, PROFESSIONAL SERVICES AND GENERAL SERVICE CONTRACTS

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex. Except with respect to affectional or sexual orientation, the contractor will take affirmative action to ensure that such applicants are recruited and employed and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex. Such action shall include, but not be limited to the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates or pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Public Agency Compliance Officer setting forth provisions of this non-discrimination clause.

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex.

The contractor or subcontractors, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor and subcontractor, where applicable, agrees to comply with the regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor and subcontractor agrees to attempt in good faith to employ minority and female workers consistent with the applicable county employment goals established in accordance with N.J.S.A. 17:27-5.2, or a binding determination of the applicable county employment goals determined by the Division, pursuant to N.J.S.A. 17:27-5.2.

The contractor and subcontractor agrees to inform in writing its appropriate recruitment agencies including, but not limited to, employment agencies, placement bureaus, colleges, universities, labor unions, that it does not discriminate on the basis or age, race, creed, color, national origin, ancestry, martial status, affectional or sexual orientation, or sex, and that it will discontinue to use of any recruitment agency which engages in direct or indirect discriminatory practices.

The contractor and subcontractor agrees to revise any of its testing procedures, if necessary, to assure that all personnel testing conforms with the principles of job-related testing, as established by the statutes and court decisions of the State of New Jersey and as established by applicable Federal law and applicable Federal court decisions.

The contractor shall submit to the public agency, after notification of award but prior to execution of a goods and services contract, one of the following three documents:

Letter of Federal Affirmative Action Plan Approval

Certificate of Employee Information Report

Employee Information Report Form AA302

The contractor and its subcontractor shall furnish such reports or other documents to the Division of Contract Compliance & EEO as may be requested by the Division from time to time in order to carry out the purposes of these regulations, and public agencies shall furnish such information as may be requested by the Division of Contract Compliance & EEO for conducting a compliance investigation pursuant to Subchapter 10 of the Administrative Code at N.J.A.C. 17:27.
